
SM Herrington thanked all for the help in the installation.

SM Herrington presented a Red Branch of Eri membership card to PSM James T. Elliott, Jr..

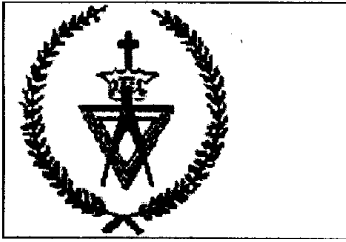
The minutes of the meeting were read and approved as read.
