The Eminent Prior welcomed all present.

S.K. William Johnson Littel, having accepted the invitation and his fee having been paid, was announced in waiting and was admitted and received into membership in Jesse Green Priory No. 70. The Ceremony of Reception was conferred by P.P. Henry G. Law assisted by the other officers, with the lectures being given by Donald D. Thomas, KYGCH - LODGE; T. Eugene Womach - CHAPTER; James Richardson - COUNCIL; Franklin R. Townsend - COMMANDERY. The members jewel was presented by P.P. Henry G. Law, KYGCH.

The Minutes of the annual meeting held on October 20, 1990 and the business meeting held on May 4, 1991, were read and approved as read. The Treasurer's report showed a current balance of \$620.40.

host Priory for Convent General Conclave to be held in Wilmington in late September or early October.


Em. Prior Sullivan appointed Richard A. Scarlott as chairman of the committee for this Convent General Conclave.
